- (1) On July 16, 2008, the common stock of Fluor Corporation split 2-for-1, resulting in the reporting person's ownership of 37,525 additional shares of stock.

- (3) On July 16, 2008, the common stock of Fluor Corporation split 2-for-1, resulting in the reporting person's ownership of 117 additional shares of stock as custodian for his child.

- (7) Each restricted unit represents a contingent right to receive the cash value of one share of Fluor common stock.
- (8) On July 16, 2008, the common stock of Fluor Corporation split 2-for-1, resulting in the reporting person's ownership of 52 additional restricted units.
