This transaction represents the withholding by Issuer of shares to pay taxes in connection with the vesting of a Restricted Stock Unit ("RSU") award. The timing and amount of the transaction were determined by the terms of the applicable RSU award and were not within the control of the Reporting Person.

(1) The Form 4 filed on February 2, 2011 erroneously reflected the vesting of 9,310 RSUs on January 31, 2011, but only 6,367 RSUs vested on that date. The combined total of Common Stock and RSUs in Column 5, which were previously reported as separate line items in Table I, accurately reflected, on a combined basis, the directly owned Common Stock and RSUs of the reporting person.
