- (1) These shares of common stock vested and were delivered upon the satisfaction of a certain performance condition in a performance-based restricted stock unit.

- (3) The reported transactions were executed at sales prices ranging from \$6.15 to \$6.37. The vested shares have been deferred pursuant to a deferral plan by the reporting person.
