(1) The option is exercisable in five equal annual installments. The first installment becomes exercisable on January 18, 2014.

(2) Restricted Stock granted on February 2, 2011 will vest in 33 1/3% installments over three years each February 2nd.

(3) The option is exercisable in five equal annual installments. The first installment becomes exercisable on April 18, 2014.

The performance goal will be met as of the end of the calendar quarter when the Company has averaged \$0.625 diluted earnings per share for four consecutive quarters or \$2.50 total diluted earnings per share over a period of four consecutive quarters.
