(1) The restricted stock units will vest at a rate of 25% annually on February 12 from the years 2015 through 2018.

(2) The restricted stock units will vest 100% on the third anniversary of the grant date.

Amount does not include performance-based restricted stock units granted to the executive officer on February 12, 2014, as performance awards not tied to stock price are not derivative securities for purposes of Section 16 under guidance from the staff of the SEC. The number of performance-based restricted stock units that the executive officer will receive will be determined at the end of the 3-year performance period and will be dependent upon the achievement of cumulative 3-year EPS and average return-on-equity performance metrics approved by the Compensation and Human Resources Committee. The target number of performance-based restricted stock units is 21,356.

(4) The non-qualified stock options vest at a rate of 25% annually on February 12 from the years 2015 through 2018.
