Restrictions lapse as to 3,337 shares on April 1, 2016, July 1, 2016, October 1, 2016, January 1, 2017, 2187 on April 1, 2017, July 1, 2017, October 1, 2017; 2195 on January 1, 2018 and 1250 on April 1, 2018, July 1, 2018, October 1, 2018 and January 1, 2019.
