- (1) On August 1, 2016, 15,569 shares of restricted stock were issued to the Reporting Person by the Issuer. These shares vest in four (4) annual installments beginning on August 1, 2017 as follows: 3,892 shares vest on each of August 1, 2017, August 1, 2018, and August 1, 2019, and 3,893 shares vest on August 1, 2020.
- (2) On August 1, 2016, options to purchase 73,255 shares were granted to the Reporting Person by the Issuer.
