- (1) Includes 401(k) contributions used to purchase PGC stock each payroll period.

- (6) The restricted stock units will cliff vest on the third anniversary of the grant date subject to certain performance conditions being satisfied.
- (7) The options are exercisable in five equal annual installments on June 2, 2009, 2010, 2011, 2012 and 2013.
