**GOL Launches Flight to Boa Vista**

**São Paulo, September 16, 2005** GOL Linhas Aéreas Inteligentes (NYSE: GOL and Bovespa: GOLL4), Brazil's low-fare, low-cost airline, today began operating daily flights to Boa Vista, Roraima (population 324,397). The new flights will connect through Boa Vista, Manaus, Brasília, Rio de Janeiro (Galeão) and, on the return, through Rio de Janeiro (Galeão), Brasília, Manaus, Boa Vista, with connections to Sao Paulo and *all* other destinations to which GOL operates.

As one of the most beautiful cities in the northern region of Brazil; Boa Vista is an increasingly popular destination for both national and international tourists given its proximity to Manaus and its shared border with Venezuela, said Tarcísio Gargioni, vice-president of Marketing and Services for GOL. With the addition of this flight, GOL will serve all of Brazil's state capitals.
