In order to facilitate and encourage shareholders with voting rights to participate, the Company will allow shareholders to vote on the items that appear in the General Meeting Notice over the Internet by using the public request for proxies, as per CVM Instruction 481, published on December 17 2009.

The electronic proxies will be received via the Online Meeting platform, at **[www.assembleiasonline.com.br](http://www.assembleiasonline.com.br)**. Shareholders must register in the platform as soon as possible in order to use it. The proxy, showing the shareholder's voting intention (electronic voting), must be sent through the system between April 9 and 19, 2010. For more details on how to vote via the Online Meeting Platform, read the **Manual**.

By providing this alternative, Petrobras seeks to strengthen its commitment to the adoption of the best corporate governance and transparency practices.

Holders of American Depositary Receipts (ADR) cannot use this tool and must continue voting by means of the proxy sent to depository bank JPMorgan Chase.
