### **Contracting for pre-salt development**

Rio de Janeiro, April 29, 2010   Petróleo Brasileiro S.A - Petrobras, informs about the execution of an agreement for the development of the pre-salt region in Santos Basin.

The Company signed a letter of intent with Engevix Engenharia S.A. to authorize Engevix to start up the procurement services for the construction of eight FPSO ( Floating, Production, Storage and Offloading ) hulls. These units are expected to be allocated in the pre-salt area of Santos Basin.

The letter of intent was signed aimed at avoid delays in the development schedule of the area and will follow to the execution of a final contract by the parties, after the formal approval of Petrobras' partners.
