(1) On July 26, 2006, the reporting person filed a Form 4 that mistakenly overstated his ESOP holdings in company common stock by 5,428 shares. As of July 26, 2006, the reporting person had a direct beneficial ownership interest in 264,347 shares (as stated in Table I) and an indirect beneficial ownership interest 10,000 shares held in a trust, 1,361 shares held in a custodial account for his daughter, 1011 shares held in a custodial account for his son, 2,282 shares held in an ESOP, and 159 held in a 401(k).
