Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

On November 20, 2006, the Board of Directors elected Mr. Jack Guynn as a Director of the Company to fill a vacancy resulting from an increase in the number of directors from twelve to thirteen. Mr. Guynn will serve until the Company's 2007 Annual Meeting of shareholders. Mr. Guynn recently retired as President and Chief Executive Officer of the Federal Reserve Bank of Atlanta.
