## Edgar Filing: Morhaime Michael - Form 4

- On November 7, 2011, 23,334 restricted stock units held by Mr. Morhaime vested. Pursuant to the terms of his restricted stock unit award
- (1) agreement, he elected to have the Company withhold 10,893 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.
  - (2) Following the receipt thereof, Mr. Morhaime transferred the net shares he received in connection with the vesting of his 23,334 restricted stock units to the Michael Morhaime Revocable Trust.
  - (3) Following the transactions reported on this Form 4, Mr. Morhaime directly held 446,666 restricted stock units, each representing the right to receive one share of the Company's common stock.
  - (4) Following the transactions reported on this Form 4, Mr. Morhaime (through the Michael Morhaime Revocable Trust) indirectly held 12,441 shares of the Company's common stock.
  - (5) These securities are held by the Michael Morhaime Revocable Trust.
