On February 15, 2013, the restrictions lapsed with respect to 30,000 restricted shares of the Company's common stock held by Mr. Tippl.

(1) Pursuant to the terms of his restricted stock award agreement, the Company withheld 15,654 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.

(2) These securities are held by the Thomas and Laura Tippl Family Trust.

On February 15, 2013, 87,500 restricted stock units held by Mr. Tippl vested. Pursuant to the terms of his restricted stock unit award

(3) agreement, the Company withheld 35,466 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.

On February 15, 2013, the restrictions lapsed with respect to 56,250 performance-based restricted shares of the Company's common stock

(4) held by Mr. Tippl. Pursuant to the terms of his restricted stock award agreement, the Company withheld 29,352 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.

Following the transactions reported on this Form 4, Mr. Tippl (through the Thomas and Laura Tippl Family Trust) held (a) 481,142

(5) shares of the Company's common stock, (b) 30,000 restricted shares of the Company's common stock, (c) 87,500 restricted stock units, each representing the right to receive a share of the Company's common stock, and (d) 56,250 performance-based restricted shares of the Company's common stock.
