This Amendment No. 1 to Schedule 13G (the "Schedule 13G") is being filed on behalf of Sapling, LLC, a Delaware limited liability company ("Sapling"), Fir Tree Capital Opportunity Master Fund, L.P., a Cayman Islands exempted limited partnership ("Fir Tree Capital Opportunity") and Fir Tree, Inc., a New York corporation ("Fir Tree"), relating to common stock, par value \$0.0001 (the "Common Stock") of Great Lakes Dredge & Dock Corporation, a Delaware corporation (the "Issuer"), purchased by Sapling and Fir Tree Capital Opportunity.
