- (1) Between November 14, 2007 and January 3, 2008, the Reporting Person acquired 35 shares of DRE common stock through dividend reinvestment.
- (2) The Stock Options were fully vested on the grant date.
- (3) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/25/05.
- (4) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/31/06.
- (5) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/30/07.
- (6) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/29/08.

- (9) Represents phantom stock units accrued under the Weeks Corporation 1998 Deferred Compensation Plan. Between November 14, 2007 and January 3, 2008, the Reporting Person acquired 38 shares of the Company's common stock through dividend reinvestment. All amounts accrued under the plan are to be paid in cash upon the Reporting Person's termination as a director of the Issuer.
