

ITEM 7.01. REGULATION FD

On November 7, 2016, Kennedy Wilson Europe Real Estate plc (“KWE,” LSE: KWE) issued a release with respect to its payment of the stock portion of the quarterly management fee due to KW Investment Management Ltd., its external manager and a wholly-owned subsidiary of Kennedy-Wilson Holdings, Inc. (the “Company”). A copy of the release is furnished herewith as Exhibit 99.1

On November 7, 2016, the Company received a total of 206,460 ordinary shares from KWE that KWE purchased in the open market, as part payment of the quarterly management fee for the quarter ended September 30, 2016. After such transactions, the Company owns approximately 22.7% of the total issued share capital of KWE. A wholly-owned subsidiary of the Company incorporated in Jersey also serves as KWE’s external manager pursuant to an investment management agreement.
