## Edgar Filing: Armour Residential REIT, Inc. - Form 4

On October 6, 2014, the reporting person elected to redeem 251 shares of vested phantom stock previously granted under ARMOUR Residential REIT, Inc.'s Amended and Restated 2009 Stock Incentive Plan into 251 shares of ARMOUR's common stock and received 4,285 shares of ARMOUR common stock pursuant to quarterly compensation paid for the reporting person's service on ARMOUR's Board of Directors. Commencing with the end of the first quarter of 2013, the reporting person may elect to receive up to \$16,500 of the reporting person's total quarterly compensation (or \$66,000 on an annual basis), paid in stock. However, the reporting person may elect to receive some or all of the stock compensation as cash. The 4,285 shares of stock represent the reporting person's election of stock compensation for the past quarter.

- Represents shares owned indirectly through Georgiana Investments L.P., which were previously owned indirectly through Staton Family Investments LLC. The reporting person is a general partner and a limited partner of DM Staton Family L.P., which has an equity interest in Georgiana Investments L.P. The reporting person has a pecuniary interest in the shares held by Georgiana Investments L.P.
- (2) Previous Forms 4 misreported Mr. Staton's direct ownership to include an additional 227,083 shares of common stock and Mr. Staton's indirect ownership to exclude an additional 202,008 shares of common stock.
