- On March 4, 2009 the reporting person was granted performance based restricted stock with performance criteria related to earnings per share and expense targets to be achieved by the Company in 2009. The Management Development and Compensation Committee on February 9, 2010 confirmed the performance criteria were partially met, which resulted in 94.58 percent attainment for the 2009 restricted stock grants. Forfeiture restrictions on the reported shares will lapse upon continued employment of the reporting person through February 9, 2012.
