INTRODUCTORY STATEMENT

This Amendment No. 2 ("Amendment") amends and supplements the Tender Offer Statement on Schedule TO (as amended and supplemented, the "Schedule TO") filed by CompuCredit Holdings Corporation, a Georgia corporation ("CompuCredit" or the "Company"), with the Securities and Exchange Commission on August 15, 2012, as amended by Amendment No. 1 to Schedule TO filed by the Company on September 13, 2012, relating to an offer by the Company to purchase for cash up to 8,250,000 shares of the Company's outstanding common stock, no par value per share (the "Common Stock" or "Shares"), at a purchase price of \$10.00 per share. The Offer is made upon the terms and subject to the conditions contained in the Offer to Purchase, dated August 15, 2012 (as amended or supplemented from time to time, the "Offer to Purchase"), a copy of which has been previously filed, and the accompanying Letter of Transmittal (as amended or supplemented from time to time, the "Letter of Transmittal"), a form of which has been previously filed. All capitalized terms used but not defined herein shall have the meanings assigned to them in the Offer to Purchase incorporated by reference herein.

This Amendment reports the final results of the Offer and is filed in satisfaction of the reporting requirements of Rule 13e-4(c)(4) promulgated under the Securities Exchange Act of 1934, as amended. The information set forth in the Offer to Purchase and the Letter of Transmittal is incorporated by reference herein in response to all items in this Schedule TO, except that such information is amended and supplemented to the extent specifically provided herein.

Item 4. Terms of the Transaction.

(a) Material Terms. Item 4 of the Schedule TO is hereby amended and supplemented to add the following:

The Offer expired at 11:59 p.m., New York City time, on September 12, 2012. Based on the count by the Depositary, as of the Expiration Date, 22,671,663 shares of Common Stock were validly tendered and not withdrawn in the Offer. In accordance with the terms and conditions of the Offer and based on the count by the Depositary, CompuCredit has accepted for payment 8,250,000 shares of Common Stock at a purchase price of \$10.00 per share, for a total cost of approximately \$82.5 million, excluding fees and other expenses in connection with the Offer. The number of shares of Common Stock that CompuCredit has accepted for purchase represents approximately 34.9% of the shares of Common Stock outstanding. CompuCredit has been informed by the Depositary that the final proration factor is approximately 36.4%. The Depositary will promptly issue payment for the shares validly tendered and accepted for purchase and will return all other shares tendered.

On September 18, 2012, the Company issued a press release announcing the final results of the Offer. A copy of the press release is filed as Exhibit (a)(5)(iii) to this Schedule TO and is incorporated herein by reference.
