- (1) Common stock acquired upon vesting of Restricted Stock Units ("RSUs") granted on June 25, 2015.
- (2) Each RSU represents a contingent right to receive one share of HomeStreet common stock. RSUs do not require the holder to pay any consideration on vesting.  
 On June 25, 2015 the reporting person was granted 1,008 RSUs, which vest incrementally in equal amounts on June 25, 2016, June 25, 2017, and June 25, 2018, respectively. In the event of a change in control, all unvested RSUs may vest immediately under certain circumstances. Upon vesting, the reporting person will receive a number of shares of HomeStreet common stock equal to the number of RSUs that vest on that date.
- (3) The reporting person's remaining RSUs includes 393 RSUs granted on January 28, 2016, which vest on January 28, 2019, 620 RSUs granted on January 26, 2017, which vest incrementally in equal amounts on January 26, 2019 and January 26, 2020, and 1,275 RSUs granted on January 29, 2018, which vest incrementally in equal amounts on January 29, 2019, January 29, 2020 and January 29, 2021, respectively. In the event of a change in control, all unvested RSUs may vest immediately under certain circumstances. Upon vesting, the reporting person will receive a number of shares of HomeStreet common stock equal to the number of RSUs that vest on that date.
