- (1) Ms. Bolomey exercised 607 stock options at \$11.48 through a "net-out" with the Company based on the stock price of \$15.90, resulting in the issuance of 169 shares of common stock.
- (2) There was a 10% stock dividend payable on September 30, 2016, for which Ms. Bolomey received additional shares.
- (3) 607 stock options were granted on 1/25/07, which vest 1/3 each year commencing 1/25/08; 1/25/09 and 1/25/10 and expires on 1/25/17. Ms. Bolomey received 169 shares of common stock through a "net-out" with the Company on 12/8/16.
- (4) 77,578 stock options were granted to Ms. Bolomey of which 55,578 are currently exercisable.
