(3) The RSUs, originally granted to the Reporting Person under the Seagate Technology plc 2012 Equity Incentive Plan (the "Plan") for 3,350 shares, of which 2,512 have been released, vest as to one-quarter of the shares on September 9, 2016 and each one-year anniversary thereafter.

(4) The RSUs, originally granted to the Reporting Person under the Plan for 7,775 shares, of which 3,887 have been released, vest as to one-quarter of the shares on September 9, 2017 and each one-year anniversary thereafter.
