Data I/O Corporation entered into a 3rd Amendment to its Redmond, Washington headquarters lease with its landlord, Arden Realty with the joint execution completed June 1, 2015. The amendment changes the building location to 6645 185<sup>th</sup> Ave N.E., extends the term to April 2021, reduces the space rented to 20,240 square feet from 33,676, and reduces the rent rate slightly. The amended new building lease is expected to begin in July 2015 and the maximum rent commitment for it is approximately \$1.7 million plus operating triple net expenses, with a projected cash savings of approximately \$1.5 million, over the lease period.
