(1) Performance Share Units (PSUs) awarded April 1, 2011 had its performance results certified, and then shares vested, on April 1, 2014 at 150% achievement based on total shareholder return (TSR) relative to a peer group. The peer group consisted of the Philadelphia Semiconductor Index (SOXX) companies at grant, with relative TSR measured over a three year measurement period. Each PSU is convertible into one share of Kulicke and Soffa Industries Inc. common stock.
