BAVP beneficially owns and has the shared power to control the voting and disposition of an aggregate of 210,764 shares of common stock of the Issuer. Based on 39,069,868 shares of common stock reported to be outstanding on the Issuer's Prospectus Supplement dated February 10, 2004, BAVP beneficially owns less than 1% of the outstanding shares of the Issuer's common stock. In addition, BAVP beneficially owns 100,000 shares of the Issuer's Series A Convertible Preferred Stock. On July 8, 2004, such shares will be convertible into 1,000,000 shares of the Issuer's common stock. Even assuming the conversion of these shares of Series A Convertible Preferred Stock, BAVP would beneficially own less than 5% of the outstanding shares of the Issuer's common stock.

Venture Partners, as the sole general partner of BAVP, may be deemed to be the indirect beneficial owner and to have shared power to control the voting and disposition of an aggregate of the 210,764 shares of common stock beneficially owned by BAVP, representing less than 1% of the outstanding shares of the Issuer's common stock.

Bank of America, as the employer of the members of the Advisory Committee to BAVP (which must approve all investment transactions of BAVP), may be deemed to be the indirect beneficial owner and to have shared power to control the voting and disposition of an aggregate of the 210,764 shares of common stock beneficially owned by BAVP, representing less than 1% of the outstanding shares of the Issuer's common stock.
