Item 5.07 Submission of Matters to a Vote of Securities Holders

The 2018 Annual Meeting of Shareholders of The First Bancorp, Inc., the one-bank holding company of First National Bank was held at Samoset Resort, 220 Warrenton Street, Rockport, Maine 04856, on Wednesday, April 25, 2018, at 11:00 a.m. Eastern Daylight Time, for the following purposes:

1. To elect as Directors of the Company the nominees listed in the Company's Proxy Statement dated March 19, 2018.
2. To approve (on a non binding basis) the compensation of the Company's executives.
3. To ratify the Audit Committee's selection of Berry Dunn McNeil & Parker, LLC as independent auditors of the Company for 2018.
4. To transact such other business as may properly come before the meeting or any adjournment thereof.

At the Annual Meeting, there were present in person or by proxy 9,516,392 shares of the Company's common stock, representing 87.74% of the total outstanding eligible votes. The final voting results for each proposal are as follows:
