On March 2, 2011, the Board of Directors of EMCORE Corporation (the "Company") elected Dr. James A. Tegnalia to the Board of Directors as a Class C Director. Dr. Tegnalia's term on the Board of Directors began on March 2, 2011 and will expire at the Company's annual meeting of stockholders in 2012. Dr. Tegnalia is not expected to be named at this time to any of the committees of the Board of Directors.
