Item 7.01 Regulation FD Disclosure.

I. Price Risk Management

(a) With the objective of enhancing the certainty of future revenues, from time to time EOG Resources, Inc. (EOG) enters into New York Mercantile Exchange related financial commodity collar and price swap contracts. EOG accounts for these financial commodity derivative contracts using the mark-to-market accounting method. In addition to financial transactions, EOG is a party to various physical commodity contracts for the sale of hydrocarbons that cover varying periods of time and have varying pricing provisions. The financial impact of physical commodity contracts is included in revenues at the time of settlement, which in turn affects average realized hydrocarbon prices.

(b) For the first quarter of 2007, EOG anticipates a total loss of \$39.8 million from both natural gas and crude oil financial price swap contracts. During the first quarter of 2007, net cash inflow was \$47.3 million related to settled natural gas and crude oil financial price swap contracts.

II. Natural Gas Financial Collar and Price Swap Contracts

(a) For the first quarter of 2007, EOG anticipates a loss of \$38.4 million from natural gas financial price swap contracts. During the first quarter of 2007, net cash inflow was \$42.2 million related to settled natural gas financial price swap contracts.

(b) EOG has not entered into any additional natural gas financial price swap contracts since EOG filed its Annual Report on Form 10-K on February 28, 2007, which provided an update of all such financial contracts as of that date. Currently, EOG is not a party to any financial collar contracts. The average price of EOG's natural gas financial price swap contracts outstanding is \$9.19 per million British thermal units. Presented below is a comprehensive summary of EOG's natural gas financial price swap contracts as of April 3, 2007, with notional volumes expressed in million British thermal units per day (MMBtud) and prices in dollars per million British thermal units (\$/MMBtu).

III. Crude Oil Financial Price Swap Contracts

(a) For the first quarter of 2007, EOG anticipates a loss of \$1.4 million from crude oil financial price swap contracts. During the first quarter of 2007, the net cash inflow was \$5.1 million related to settled crude oil financial price swap contracts.

(b) EOG has not entered into any additional crude oil financial price swap contracts since EOG filed its Annual Report on Form 10-K on February 28, 2007, which provided an update of all such financial contracts as of that date. The average price of EOG's crude oil financial price swap contracts outstanding is \$78.13 per barrel. Presented below is a comprehensive summary of EOG's crude oil financial price swap contracts as of April 3, 2007, with notional volumes expressed in barrels per day (Bbld) and prices in dollars per barrel (\$/Bbl).
