ITEM 9. REGULATION FD DISCLOSURE

The ATWOOD HUNTER is currently idle offshore Egypt preparing to mobilize for its next contract. The rig has been awarded a contract by Isramco, Inc. to drill one well off the coast of Israel, which should commence in early September 2003 and should take approximately 30 days to complete. The contract provides for a dayrate of \$44,000. Future contract opportunities for additional work are being pursued in the Mediterranean area, as well as outside of the Mediterranean.

In early August 2003, the ATWOOD BEACON commence working under a contract with Murphy Sarawak Oil Co. Ltd. ("Murphy") which provided for the drilling of

three firm wells plus options to drill five additional wells off the coast of Malaysia. Murphy has now exercised its option to extend the contract for the additional five wells. All eight wells will have a dayrate in the low \$50,000's and should take until January/February 2004 to complete. Contract opportunities for additional work following completion of the Murphy contract are being pursued.

The RICHMOND is currently drilling one well for Spinnaker Exploration Company, L.L.C. ("Spinnaker") which is expected to be completed during the first half of September 2003. Immediately upon completion of the Spinnaker contract, the rig will commence a two-well plus one option well contract for Union Oil Company of California ("Unocal"). The Unocal contract provides for a dayrate of \$24,000 with the two firm wells expected to take around 50 days to complete.

The ATWOOD SOUTHERN CROSS has been relocated to Egypt where it is currently stacked while waiting for its next contract opportunity. Contract opportunities for additional work are being pursued in the Mediterranean Area, as well as in other areas of the world.

Additional information with respect to the Company's Contract Status Summary August 21, 2003 is attached hereto as Exhibit 99.1 which is being furnished in accordance with Rule 101 (e)(1) under Regulation FD and should not be deemed to be filed.

Statements contained in this report with respect to the future are forward-looking statements. These statements reflect management's reasonable judgment with respect to future events. Forward-looking statements involve risks and uncertainties. Actual results could differ materially from those anticipated as a result of various factors: the Company's dependence on the oil and gas industry; the risks involved in the construction of a rig; competition; operating risks; risks involved in foreign operations; risks associated with possible disruption in operations due to terrorism; risks associated with a possible disruption in operations due to war; and governmental regulations and environmental matters.
