Mr. Gomez Pimienta is the President and Chief Executive Officer of Impulsora and owns almost 23% of its outstanding stock. Nevertheless, pursuant to Exchange Act Rule 16a-1(a)(4), Mr. Gomez Pimienta disclaims beneficial ownership of the securities of the Issuer held by Impulsora.
