TELEVISA ANNOUNCES EARLY TERMINATION OF WAITING PERIOD UNDER THE HART-SCOTT-RODINO ACT

November 9, 2010, Mexico City, Mexico - Grupo Televisa, S.A. ("Televisa"; NYSE:TV; BMV:TLEVISA CPO) ("the Company") announced that early termination of the waiting period under the Hart-Scott-Rodino Act with respect to its previously announced investment in the parent company of Univision Communications Inc. was granted on November 8, 2010. The investment remains subject to satisfaction of additional closing conditions. Subject to fulfillment of these conditions, the transaction is currently expected to close by the end of 2010.
