On January 27, 2014, the Issuer announced that it had completed its acquisition of Health Management Associates, Inc. ("HMA"). In connection with this acquisition, the Reporting Persons received, among other consideration, 2,621,125 Shares in exchange for 37,757,583 shares of HMA common stock, at an exchange rate of 0.06942 Shares per each share of HMA common stock and adjusted for the cash received in lieu of fractional Shares. As a result, as of January 29, 2014, each of Glenview Capital Management and Mr. Robbins may be deemed the beneficial owner of 12,093,795 Shares. This amount consists of: (A) 495,375 Shares held for the account of Glenview Capital Partners; (B) 4,942,933 Shares held for the account of Glenview Capital Master Fund; (C) 2,274,424 Shares held for the account of Glenview Institutional Partners; (D) 2,549,086 Shares held for the account of Glenview Offshore Opportunity Master Fund; and (E) 1,831,977 Shares held for the account of Glenview Capital Opportunity Fund.

As of January 29, 2014, each of the Reporting Persons may be deemed the beneficial owner of approximately 10.67% of Shares outstanding. (On January 27, 2014, the Issuer announced it had completed its acquisition of Health Management Associates, Inc. In connection with this acquisition, the Issuer expected to issue approximately 18,361,256 Shares, according to the amended Form S-4 filed by the Issuer on November 18, 2013. For purposes of calculating the beneficial ownership percentage herein, these 18,361,256 Shares have been added to the 94,972,160 Shares outstanding as of October 25, 2013, reported by the Issuer in its quarterly report on Form 10-Q, filed October 31, 2013, for a total of approximately 113,333,416 Shares outstanding.)
