- (ii) partnerships, including MHFII, Holdings may be deemed to beneficially own the 256,600 shares of Common Stock, which are held by such partnerships, constituting approximately 7.5% of the shares outstanding.  
MCM owned directly no shares of Common Stock. By reason of its position as investment advisor, MCM may
- (iii) be deemed to beneficially own the 335,000 shares of Common Stock, which are held of record by clients of MCM, constituting approximately 9.82% of the shares outstanding.  
Mr. Maltese directly owned no shares of Common Stock. By reason of his position as Managing Member of
- (iv) MCM, Mr. Maltese may be deemed to beneficially own 335,000 shares of Common Stock, constituting approximately 9.82% of the shares outstanding.
