The additional shares of restricted stock will vest as follows: 52 shares in even increments over 2 years beginning January 2, 2017, 57 shares in even increments over 3 years beginning January 2, 2017, 141 shares in even increments over 3 years beginning August 25, 2017, 169 shares in even increments over 4 years beginning January 2, 2017 and 209 shares in even increments over 5 years beginning January 4, 2017.
