Item 1. Security and Issuer

The class of equity securities to which this statement relates is the common stock, par value \$0.01 (the "Common Stock") of CBL & Associates Properties, Inc., a Delaware corporation (the "Issuer"). The principal executive

### Item 2. Identity and Background

The name of the person filing this statement is Stichting Pensioenfonds ABP, an entity established under the laws of The Kingdom of the Netherlands (the "Fund"), whose principal business is investing funds held on behalf of public sector employees of The Kingdom of the Netherlands. The address of the Fund's principal executive office is Oude Lindestraat 70, Postbus 2889, 6401 DL Heerlen, The Netherlands. The name, citizenship, business address and present principal occupation or employment, as well as the name and address of any corporation or other organization in which such occupation or employment is conducted, of each of the directors and executive officers of the Fund are as follows:

To the knowledge of the Fund, during the last five years, neither the Fund nor any of its executive officers or directors has been (i) convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors) or (ii) a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding is or was subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

### Item 3. Source and Amount of Funds or Other Consideration

The funds for the purchases of Common Stock made by the Fund on the open market were supplied from Dutch public sector pensioners' contributions to the Fund.

### Item 4. Purpose of Transaction

The Fund from time to time intends to review its investment in the Issuer on the basis of various factors, including the Issuer's business, financial condition, results of operations and prospects, general economic and industry conditions, the securities markets in general and those for the Issuer's securities in particular, as well as other developments and other investment opportunities. Based on such review, the Fund will take such actions in the future as the Fund may deem appropriate in light of the circumstances existing from time to time. If the Fund believes that further investment in the Issuer is attractive, whether because of the market price of the Issuer's securities or otherwise, it may acquire additional securities of the Issuer either in the open market or in privately negotiated transactions. Similarly, depending on market and other factors, the Fund may determine to dispose of some or all of the Common Stock currently owned by the Fund or otherwise acquired by the Fund either in the open market or in privately negotiated transactions.

Except as set forth above, the Fund has not currently formulated any definitive plans or proposals which relate to or would result in: (a) the acquisition by any person of additional securities of the Issuer or the disposition of securities of the Issuer, (b) an extraordinary corporate transaction involving the Issuer or any of its subsidiaries, (c) a sale or transfer of a material amount of the assets of the Issuer or any of its subsidiaries, (d) any change in the present board of directors or management of the Issuer, (e) any material change in the

Issuer's capitalization or dividend policy, (f) any other material change in the Issuer's business or corporate structure, (g) any change in the Issuer's charter or bylaws or other instrument corresponding thereto or other action which may

impede the acquisition of control of the Issuer by any person, (h) causing a class of the Issuer's securities to be deregistered or delisted, (i) a class of equity securities of the Issuer becoming eligible for termination of registration or (j) any action similar to any of those enumerated above.

### Item 5. Interest in Securities of the Issuer

(a) The Fund is the sole beneficial owner of 1,500,000 shares of Common Stock representing 5.14% of the outstanding shares of the Issuer's Common Stock. The calculation of the foregoing percentage is based on the number of shares of Common Stock disclosed as outstanding by the Issuer in its Quarterly Report on Form 10-Q for the quarterly period ended March 31, 2002.

(b) The Fund has the sole power to vote or to direct the vote or dispose or direct the disposition of 1,500,000 shares of Common Stock. To the knowledge of the Fund, there are no shares of Common Stock which are beneficially owned by any director or executive officer listed under Item 2.

(c) On March 11, 2002, the Fund purchased 500,000 shares of Common Stock at a price of \$34.55. On March 22, 2002, the Fund purchased 50,000 shares of Common Stock at a price of \$35.50 per share. On March 28, 2002, the Fund purchased 20,000 shares of Common Stock at a price of \$35.50 per share. On April 16, 2002, the Fund purchased 16,200 shares of Common Stock at a price of \$37.14 per share. On April 23, 2002, the Fund purchased 13,800 shares of Common Stock at a price of \$36.50 per share. On April 25, 2002, the Fund sold 31,000 shares of Common Stock at a price of \$36.81 per share. On May 2, 2002, the Fund sold 35,900 shares of Common Stock at a price of \$37.38 per share. On May 7, 2002, the Fund sold 24,900 shares of Common Stock at a price of \$36.56 per share. On May 8, 2002, the Fund sold 42,000 shares of Common Stock at a price of \$36.03 per share. On May 9, 2002, the Fund sold 1,900 shares of Common Stock at a price of \$36.00 per share. On May 21, 2002, the Fund sold 11,200 shares of Common Stock at a price of \$35.35 per share. On May 22, 2002, the Fund sold 129,000 shares of Common Stock at a price of \$35.39 per share. On June 7, 2002, the Fund sold 74,100 shares of Common Stock at a price of \$37.51 per share.

Except as disclosed herein, there were no transactions by the Fund in securities of the Issuer during the sixty days prior to June 7, 2002.

(d) To the knowledge of the Fund, no other person has the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, the Common Stock purchased by the Fund.
