At the request of market regulator Consob, Telecom Italia specifies that reports which have appeared in the press concerning the Group's industrial plan, as well as operations which are to be presented to the Board of Directors on 25 September 2008, are journalistic speculation.

As announced to the market on several occasions, the new Plan will be communicated by the end of the year and, in any case, only at the conclusion of the decision-making process which reserves for the Board of Directors the approval of strategic, industrial and financial plans, as is the case with all operations of particular significance. At that point, the market will be given complete, exhaustive information which, as such, will not be off the mark.

- our ability to successfully implement our internet and broadband strategy both in Italy and abroad;
- our ability to successfully achieve our debt reduction targets;
- the impact of regulatory decisions and changes in the regulatory environment in Italy and other countries in which we operate;
- the impact of economic development generally on our international business and on our foreign investments and capital expenditures;

- our services are technology-intensive and the development of new technologies could render such services non-competitive;
