TELECOM ITALIA COMPLETES THE SALE OF LOQUENDO TO NUANCE COMMUNICATIONS

Rome, 30 September 2011

Telecom Italia has completed the sale of its 99.98% stake in Loquendo to U.S. company Nuance Communications Inc.

The final price, totally paid at the closing, of around \notin 55 million derives from the sum of the enterprise value of \notin 53 million established in the agreement signed on 12 August 2011 plus the net financial position which will be determined at closing.

The sale of Loquendo, a 2001 voice technology spin-off from Telecom Italia's Research Labs, represents a further step in the process of rationalization of the Group's shareholdings and shift of focus toward its core business.
