CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 151,930,120 shares or 10.5% of the 1,444,579,122 shares of Common Shares believed to be outstanding.

Capital Guardian Trust Company, a bank as defined in Section 3(a)(6) of the Act is deemed to be the beneficial owner of 94,029,770 shares or 6.5% of the 1,444,579,122 shares of Common Shares believed to be outstanding as a result of its serving as the investment manager of various institutional accounts.
