In October 2009, we announced that we had entered into a definitive agreement with KB Marine Holdings LLC ( KB Holdings ) under which KB Holdings would acquire 100.0 percent of the outstanding equity membership interests of our wholly-owned subsidiary 380 Development, which owns approximately 676 acres in the New York City borough of Staten Island. On September 7, 2010 the Company issued a press release which announced an agreement on the extension of the closing on the Staten Island property sale.
