On December 29, 2015, Michael Bingle submitted his resignation from the Board of Directors (the “Board”) of Virtu Financial, Inc. (the “Company”) and the Board’s Compensation Committee, effective December 30, 2015, and on January 4, 2016, Joseph Osness informed the Board that he would not stand for reelection at its next annual meeting. Mr. Bingle and Mr. Osness are each managing directors at Silver Lake Partners, which exited its investment in the Company through a secondary offering that closed on November 18, 2015. Mr. Bingle and Mr. Osness are each departing in connection with such exit and not due to any disagreement with the Board or the Company’s management or any matter relating to the Company’s operations, policies or practices. Following Mr. Bingle’s resignation, the Board consists of seven directors. The Board intends to add one or more new directors as business needs and opportunities arise.
