State below in reasonable detail the reasons why Forms 10-K, 11-K, 20-F, 10-Q, N-SAR, N-CSR, or the transition report portion thereof, could not be filed within the prescribed time period.

As reported in its Current Reports on Form 8-K filed with the Securities and Exchange Commission (the "SEC") on February 27, 2003 and March 20, 2003, HEALTHSOUTH Corporation (the "Company") disclosed that the SEC and the Department of Justice ("DOJ") were investigating the financial reporting and related activity of the Company. As reported in its Current Report on Form 8-K filed with the SEC on March 26, 2003, the Company announced that in light of the SEC and DOJ investigations into its financial reporting and related activity calling into question the accuracy of the Company's previously filed financial statements, such financial statements should no longer be relied upon. In addition, the Company announced that it has engaged forensic auditors to assist the Company in reviewing the allegations in connection with the Company's financial statements and related disclosures.

Because this review is ongoing, the Company is unable to complete the preparation of its financial statements for the period ended September 30, 2003 and, therefore, will not be able to file its Quarterly Report on Form 10-Q for the period ended September 30, 2003 on a timely basis. The Company intends to file such report as soon as practicable.
